Separate books of account shall be maintained by such trust or institution in respect of the business which is incidental to the attainment of its objectives.</p> <p>d. The trust or institution shall not apply any part of its income from the property held under a trust for private religious purposes, which does not enure for the benefit of the public.</p> <p>e. The trust or institution established for charitable purpose created or established after the commencement of this Act, shall not apply any part of its income for the benefit of any particular religious community or caste.</p> <p>f. No non-genuine activity shall be carried out by the trust or institution.</p> <p>g. No such activity shall be carried on by the trust or institution which is not in accordance with all or any of the conditions subject to which it was registered.</p> <p>h. The trust or institution shall comply with the requirement of any other law, as referred to in item (B) of sub-clause (i) of clause (b) of sub-section (1) of section 12AB.</p> <p>i. The form for registration in Form No 10A has been duly filled in by providing all the information or documents and no false or incorrect information or documents have been provided.</p> <p>j. Where the trust or institution is required to furnish application for registration under sub-clause (ii) of clause (ac) of sub-section (1) of section 12A the said trust or institution shall furnish such application within the time allowed under that clause</p> <p>k.
